

Call for Nominations
for
Board of Directors
of
Nepal Center of North Carolina (NCNC)

October 5, 2021

The NCNC's Election Committee invites nominations from its members for a two-year term beginning January 1, 2022. The nominations are available for the following positions:

1. President (1)
2. Senior Vice President (1)
3. Vice President (1)
4. Executive Secretary (1)
5. Joint Secretary (1)
6. Treasurer (1)
7. Directors of Board (5)

Interested members can either self-nominate or nominate other individuals who are dues-paying members of NCNC as of September 1, 2021, or who are life members/patrons of NCNC.

Nominations must be received by the Election Committee by November 2, 2021, for consideration by following the guidelines and procedures as described below.

Nomination Requirements

The nominee must:

1. Has been a NCNC dues-paying member in good standing for at least two years prior to the election date (December 4, 2021).
2. Has attained the age of 18 years.
3. In the case of the President, in addition to the above requirements, he/she shall have served one complete term (2 years) in the BOD.

Nomination procedures

While submitting a nomination, the following procedures must be followed:

1. One individual is eligible to compete for only one position.
2. A nominator can send nominations for one or more positions.
3. The following information about the nominator must be provided:

b. Current mailing address	
c. Valid e-mail address	

d. Verifiable phone number	
e. Member as of September 1, 2021	

4. The position or positions being nominated must be clearly specified.
5. The following details for each nominee must be provided:

Required Information (Nominee)	Response
a. Position nominated	
b. Name of Nominee	
c. Current mailing address	
d. Served one complete term in BOD (For President position only)	
e. Valid e-mail address	
f. Verifiable phone number	
g. Member as of September 1, 2021	

6. A short statement must be provided by the nominator that, to his/her best knowledge, the nominee is eligible for the position according to the nomination guidelines described above and in the NCNC bylaws.
7. Nomination must be submitted no later than November 2, 2021.
8. Nomination must be submitted to the correct e-mail address at ncncElection2021@gmail.com
9. Only nominations sent to the e-mail address in #8 above will be considered by the Election Committee. Any other nomination through social media or personal e-mails will not be considered.
10. There is a fee associated with each nomination to cover election expenses. The nominator is, therefore, required to deposit the following amount in the NCNC's bank account by visiting NCNC website at <http://www.ncnepal.org/> and clicking the "Donate" button at the bottom of the page. This site will take you to the PayPal site. Nomination will be confirmed only after the fee is received.
