Nomination Guidelines for NCNC Board of Directors

Interested members are encouraged to either nominate themselves or nominate other individuals who meet the following criteria: they must be dues-paying members of NCNC as of September 1, 2025, or hold lifetime membership or patron status.

All nominations must be submitted to the Election Committee in accordance with the procedures outlined below.

Eligibility Criteria

To qualify for a position on the Board of Directors (BOD), nominees must:

- 1. Be a dues-paying NCNC member in good standing for at least two years prior to the election date.
- 2. Be at least 18 years of age.
- 3. For the position of President, the nominee must also have completed one full two-year term as a BOD member.

Nomination Procedures

When submitting a nomination, please adhere to the following steps:

- 1. Each individual may be nominated for only one position.
- 2. A nominator may submit nominations for multiple positions.
- 3. The nominator must print and complete the form provided in Appendix 1 of this document, ensuring all information is accurate.
- 4. Clearly specify the position for which the individual is being nominated.

- 5. Include a brief statement affirming, to the best of the nominator's knowledge, that the nominee meets all eligibility requirements as outlined in these guidelines and the NCNC bylaws.
- 6. Submit the nomination no later than **October 31, 2025**.
- 7. Send nominations exclusively to **election@ncnepal.org**.
- 8. Nominations submitted via social media, personal email, or other means of communication (phone call, text message etc.) will not be accepted.
- 9. A nomination fee is required to support election-related expenses. Payment must be made through the **Donate** link on the NCNC website: https://www.ncnepal.org/donate-ncnepal. Be sure to include the nominee's name and the position in the payment text box. Nominations will only be confirmed once the fee is received.
